### **National Center on Forensics**

The center provides: medicolegal learning opportunities for medical students to train as deputy medical examiners/coroners in underserved rural areas; forensic science and legal training to district attorneys, judges, and law enforcement; and opportunities among the partners to benefit current and future practitioners in the field.

# Research and Evaluation in Publicly Funded Forensic Laboratories

The program funds projects that direct research and evaluation toward the identification of the most efficient, accurate, reliable, and cost-effective methods for the identification, analysis, and interpretation of physical evidence for criminal justice purposes. These projects identify and inform the forensic community of best practices through the evaluation of existing laboratory protocols, with direct and immediate impact on laboratory efficiency and assistance in making laboratory policy decisions.

# Research and Development in Forensic Science for Criminal Justice Purposes

The program seeks to direct the findings of basic scientific research; foster research and development in broader scientific fields applicable to forensic science; and support ongoing forensic science research toward the development of highly discriminating, accurate, reliable, cost-effective, and rapid methods for the identification, analysis, and interpretation of forensic evidence for criminal justice purposes.

# Graduate Research Fellowship

The program supports innovative doctoral dissertation research relevant to preventing and controlling crime, and ensuring the fair and impartial administration of criminal justice in the U.S. It is open to doctoral students in both social and behavioral and STEM sciences.

## NIJ Research and Evaluation on Drugs and Crime

The program funds rigorous applied research on evidence-based tools, protocols, and policies for state, tribal, and local law enforcement and other criminal justice agencies that address drug trafficking, drug markets, and drug-related violence. The research focus is on criminal investigation, prosecution, drug intelligence, and community surveillance relevant to narcotics law enforcement and medicolegal death investigation.
