
Bureau of Justice Assistance (BJA) Comprehensive Opioid, Stimulant, and Substance Use Program (COSSUP)

Training, Tools, and Technical Assistance for Implementing *Guidelines for Managing Substance Withdrawal in Jails*

In June 2023, the U.S. Department of Justice's (DOJ) Bureau of Justice Assistance (BJA) and National Institute of Corrections (NIC) released *Guidelines for Managing Substance Withdrawal in Jails: A Tool for Local Government Officials, Jail Administrators, Correctional Officers, and Health Care Professionals (Guidelines).*

As noted in the press release announcing this groundbreaking document, DOJ is committed to "increasing access to evidence-based treatment for individuals with substance use disorders (SUDs) and those at risk for overdose, including individuals who are incarcerated or reentering their communities."

To that end, BJA's <u>Comprehensive Opioid, Stimulant, and</u> <u>Substance Use Program</u> (COSSUP) funding supported development of the *Guidelines*. Advocates for Human Potential, Inc., the <u>American Society of Addiction Medicine</u>, and the <u>National Commission on Correctional Health Care</u> worked with an expert committee of clinicians and jail administrators to compile recommendations, grounded in evidence-based practice, for systematically identifying individuals who are at risk for substance withdrawal and determining the appropriate level of monitoring and medical care.



Recognizing that *Guidelines* implementation will require systems change, BJA is offering training and technical assistance (TTA). The <u>COSSUP Resource Center</u> supports jails' efforts to connect individuals to evidence-based





substance withdrawal and SUD services and facilitate continuity of care upon community reentry. This central hub allows users to:

- Learn more about the *Guidelines* from a <u>fact sheet</u>, <u>frequently asked questions</u>, and <u>videos</u> featuring corrections leaders and clinicians.
- Find relevant resources, such as:
 - A <u>Readiness for Implementation Toolkit</u>, including:
 - o An implementation readiness assessment
 - Checklists for jail administrators, health care professionals, and local government officials
 - o A checklist for staff training
 - An assessment of correctional officers' training needs

- <u>Screening for Substance Use Disorders</u>—An eLearning resource for jail staff aiming to help learners understand the basics of screening for SUD among individuals entering jail
- <u>Screening for Substance Disorders in Jails</u>—A fact sheet summarizing frequently used screening instruments with descriptions of their purpose, method, administration, benefits, considerations, and cost/availability
- <u>Request TTA</u> tailored to meet individual needs. Subjectmatter experts are available to provide direct TTA to jails, either virtually or in person.
